



The Local Authorities (Code of Conduct) (Local Determination) Regulations 2003 have enhanced the importance of Standards Committees in the ethical framework. Ethical Standards Officers have, at the time of writing, referred nine cases to Monitoring Officers for local determination by Standards Committees.

The Standards Board for England recognises the vital role that Standards Committees play in promoting the Code of Conduct and aims to give them as much help as it can. To this end, we will be publishing the first issue of a quarterly *Standards Committee Newsletter* this autumn. It will be aimed at Standards Committee members, and will offer more guidance and some examples of good practice.

Investigations

The first Standards Committee hearing under the new regulations took place on 1 September 2003 and resulted in the former member being censured. There will be more hearings coming up shortly.

In the early days of the regulations, Ethical Standards Officers were contacting Monitoring Officers before making referrals to discuss whether the authorities were ready to deal with local determination.

However, Ethical Standards Officers are now giving advance notice to Monitoring Officers of potential referrals when they send out draft case reports for comments.

Research

The research organisation MORI will soon be sending questionnaires to Monitoring Officers and members as part of The Standards Board for England's research project *Satisfaction with support and guidance*. The research, which will assess satisfaction with The Standards Board for England's support and guidance, will also be sent to parish and town clerks.

The project should help to ensure that future advice and guidance provided by The Standards Board for England meets the needs of its various stakeholders. The success of the project will depend on your participation, so we hope that you will find the time to complete and return the questionnaire.



FAQ

Can independent members of Standards Committees receive allowances?

We have revised our guidance on independent members' allowances in the light of *The Local Authorities (Members' Allowances) (England) Regulations 2003*, which came into force on 1 May 2003.

Under the regulations, an authority must introduce an annual scheme for the payment of a basic allowance to its members. The scheme may also provide for the payment of other allowances including a co-optees' allowance and travelling and subsistence expenses.

A co-optees' allowance relates to a person who is not a member of the authority but is a member of a committee or sub-committee, for example an independent member of a Standards Committee.

Each authority must consider the recommendations of its independent remuneration panel as to whether it should provide for the payment of a co-optees' allowance and travelling and subsistence expenses.

Authorities must make a scheme in accordance with the regulations on or before 31 December 2003. Once the authority has made the scheme, the provisions under the *Local Government Act 1972* relating to members' allowances will no longer apply to that authority.
