

Spending Across the Council's Services


In total the Council spent £321m during 2007/08 on running its day to day services as shown in the pie chart.

Where does the money come from?

The majority of the Council's funding comes from Specific Government grants which support a range of services. For example £83m is paid as Dedicated Schools Grant from the Government.

Halton's Council Tax for the year was the 3rd lowest in the Northwest and the 29th lowest (of 354) in the country. It funds not only the council but also Cheshire Police and Fire Authorities.

The Council received £48m from redistributed Business Rates and £39m from Council Tax payments.



The Council spent £29m of Capital Resources on acquiring, improving, maintaining and refurbishing assets which was funded by:

£10m of grant income £10m from borrowing £9m internal resources

A new refuse collection fleet

3MG (Ditton Strategic Rail Freight Park)

Widnes Waterfront regeneration

Runcorn Town Hall refurbishment
