

REASON:

The report cannot be deferred due to the Town Deal Funding constraints. All grant funding must be defrayed by 31 March 2026, failure to do so, could result in the grant being lost. A decision taken on 14 March, will enable the project to complete by March 2026. A delay of even one month, would mean we will not be able to complete the works before the grant funding expires.
