1.0 PURPOSE OF THE REPORT

1.1 6 new Health & Community Transport contracts were recently offered by tender. They have been awarded by the Operational Director Highways & Transportation but in a number of cases the circumstances need to be reported for information.

2.0 RECOMMENDATION: That the report be noted.

3.0 SUPPORTING INFORMATION

- 3.1 **Contract 2106:** There were only two bids for this contract. The contract was awarded to the operator who submitted the lowest price.
- 3.2 **Contract 2140A:** There was an alternative bid submitted for this contract, which was £10.00 per day cheaper than the lowest bid. This option was to add the client to a contract that is currently running. After receiving authorisation from the client's social worker to slightly change the times of the client's regular transport, the alternative bid was awarded.
- 3.3 Contract 2141A: This contract was awarded to the operator with the lowest bid, who at first accepted. They later phoned to hand the contract back as they could not get a driver to cover the contract. There was three operators with the same price as the next lowest bid. It was awarded to Urban 7 as they previously operated the contract, so will provide continuity to the client.
- 3.3 **Contract 2148C:** There were only two bids for this contract. The contract was awarded to the operator who submitted the lowest price.
- 3.4 **Contract 2149B:** This contract was not awarded. After sending the tender out the clients transport was permanently cancelled, as the clients circumstances had changed.
