Halton Childcare Sufficiency Assessment

Executive Summary

April 2011

1.0 Context

The Childcare Act 2006 places a duty on local authorities in England to secure, so far as is reasonably practicable, that the provision of childcare is sufficient to meet the needs of parents in their area, who require childcare in order to enable them to take-up or remain in work or undertake education and training leading to work.

Local authorities are required to assess the sufficiency of childcare provision in their area at least every three years. This assessment involves the measurement of the supply and demand of formal childcare in order to identify any gaps in provision.

2.0 Methodology

A steering group was established in March 2010 to ensure that the Childcare Sufficiency Assessment (CSA) reflected the current supply and demand situation specific to Halton.

The steering group agreed that the analysis units within the CSA would reflect the following childcare markets: 0-2 year olds; 3 and 4 year olds; 5-10 year olds; 11-14 year olds and 0-17 year old children with disabilities. It was also agreed that information would be collated at the following geographical levels: ward; children's centre reach area and town to reflect the needs and childcare usage of the local community.

To support the CSA process qualitative and quantitative data was obtained from the following stakeholders: Families Information Service (FIS); Job Centre Plus; PCT; Management Information & Research Services; Parents & Carers, Childcare Providers, Children & Young People; Employers.

3.0 Supply

Information relating to the supply of childcare places was obtained from the FIS and childcare providers and collated at ward level, which allows the data to be "scaled-up" to the appropriate assessment unit.

4.0 Demand

Information relating to the demand for formal childcare was obtained from Halton Management Information & Research Services, PCT and Halton childcare providers

5.0 Qualitative Research

Postal questionnaires were sent out to the following groups to determine their views and potential demand for formal childcare: parents & carers; parents & carers of children with disabilities; childcare providers and local employers.

A series of focussed interviews were carried out with children and young people.



6.0 Structure of Halton Childcare Sufficiency Assessment

The Halton Childcare Sufficiency Assessment is structured in a way that allows the information contained in it to be viewed as a full document that details the provision of Childcare and Early Years services across Halton. Alternatively, the information can be accessed for sub-local authority areas such as ward, Children's Centre Reach Area and town.

The information in the document is also available at the level of individual childcare market segments e.g. 0-2 year old provision, 3 and 4 year old Early Years free entitlement and 5-10 year old Out of School provision.

6.1 Rationale

In May 2008 the Office of Public Management Limited (OPM) were commissioned by the Department for Children, Schools and Families (DCSF) to review a sample of childcare sufficiency assessments. One of the recommendations that came out of the resulting report was the importance of a definition of what demand means.

Following the publication of the report a series of national working groups investigated, among other things, the "scaling" up of data to best reflect demand for formal childcare in local areas.

In response to the recommendations in the OPM report Halton developed a Demand Estimation Model (see diagram 1) to determine the most accurate level of demand for all types of childcare at various geographical levels. In order to achieve this by "scaling" up the data the following factors were applied to the total child population by ward, age range and childcare type:

- Level of unemployment
- Level of Long-term illness
- Average usage of FTE place
- Average household income
- Average vacancy levels

- Percentage of lone parents
- Percentage of part-time working
- Own holiday cover (holiday provision only)

These factors will have varying impacts on the ultimate demand for formal childcare, for example, the higher the rate of unemployment and limiting long-term illness within a ward the lower the demand for formal childcare, whereas the higher the level of lone parent households and household income the greater the demand.


6.2 **Summary**

The outcomes from this model demonstrate that demand for formal childcare varies significantly from ward to ward. The more affluent wards with lower unemployment and higher household incomes display levels of demand far in excess of more disadvantaged wards.

7.0 0-2 Year Olds – Market Characteristics

7.1 Supply

In Halton and nationally, the supply of childcare in the 0-2 year old market is predominantly delivered in Day Nurseries and by childminders, although a number of pre-schools provide childcare to 2 year olds, when places are available to ensure transition to the 3 and 4 year old free entitlement.

7.2 Demand

The Childcare Act (CA) 2006 places a duty on local authorities to secure sufficient childcare in their area, however, except for the duty to delivery the free entitlement under section 7 of the CA 2006, the intention is that working parents will pay for childcare. This influence of price allows us to develop an economic model to determine the demand for formal childcare.

The take-up of formal childcare at a national level in the 0-2 year old market is 25%*, in Halton the average take-up of formal childcare is 18%, with the most disadvantaged ward in terms of the Index of Multiple Deprivation (IMD) demonstrating estimated demand of 7% while the least disadvantaged ward demonstrates estimated demand of 47%.

The close correlation between the Halton and National average and the range of estimated demand within the authority, closely linked to levels of deprivation and therefore purchasing power, acts to validate the demand model applied.

7.3 Market Analysis Unit

As parents accessing childcare for 0-2 year olds are predominantly working parents, evidence indicates that they access provision in nurseries across a town-wide area. This is practical because parents drop-off and collect children on their way to and from work. Therefore, in Halton the assessment of childcare sufficiency in the 0-2 year old market needs to take place town-wide i.e. across Runcorn and across Widnes.

8.0 3 and 4 year old Free Entitlement – Market Characteristics

8.1 Supply

The supply of childcare in the 3 and 4 year old free entitlement market is delivered in day nurseries, pre-schools, maintained nursery classes and nursery schools.

8.2 Demand

In Halton 95% of all eligible 3 and 4 year olds access some or all of their free entitlement. As children only become eligible for the free entitlement the term after their third birthday, for the purposes of demand the 3 year old population is reduced by one third. As a similar proportion of 4 year olds enter reception class before their fifth birthday, the 4 year old population is reduced by one third.

8.3 Market Analysis Unit

A significant number of parents accessing the free entitlement do not work (45% nationally)*, as such, the geographical analysis unit differs from that of the 0-2 year old market. In the free entitlement market, parents take-up provision within a more localised geographical area that is meaningful and accessible to them. To reflect this, in Halton the assessment of sufficiency takes place within the "reach area" of each of the eight Children's Centres.

9.0 3 and 4 year old Wraparound Childcare – Market Characteristics

9.1 Supply

The supply of childcare in the 3 and 4 year old wraparound market is delivered in day nurseries, and by childminders. There are a number of preschools that deliver elements of wraparound in the form of lunch clubs, this supply is counted as part of the free entitlement.

9.2 Demand

This market operates in a similar way to the 0-2 year old market segment, with working parents required to pay for the provision they access over and above the free entitlement, as such, the demand factors influencing take-up operate in a similar way.

9.3 Market Analysis Unit

As parents accessing 3 and 4 year old wraparound care are predominantly working parents, evidence indicates that they access provision in nurseries across a town-wide area. This is practical because parents drop-off and collect children on their way to and from work. Therefore, in Halton the assessment of childcare sufficiency in the 3 and 4 year old wraparound market needs to take place town-wide i.e. across Runcorn and across Widnes.

10.0 5-10 year old Out of School – Market Characteristics

10.1 Supply

The supply of childcare in the 5-10 year old OSC market is delivered in a range of private, voluntary and maintained sector settings.

10.2 Demand

Parents are required to pay for 5-10 year old OSC childcare, as such, similar demand factors that apply in the 0-2 year old and the 3 and 4 year old wraparound market determine levels of take-up in both these market segments.

10.3 Market Analysis Unit

In the 5-10 year old OSC market parents require childcare relatively close to their home or their child's school, therefore, take-up of provision is generally within a more localised geographical area that is meaningful and accessible to them. To reflect this, in Halton the assessment of sufficiency takes place within the "reach area" of each of the eight Children's Centres.

11.0 5-10 year old Holiday Provision – Market Characteristics

11.1 Supply

The supply of childcare in the 5-10 year old Holiday market is delivered in a range of private and voluntary sector settings.

11.2 Demand

Parents are required to pay for 5-10 year old Holiday childcare, therefore, similar demand factors that apply in the 0-2 year old and the 3 and 4 year old wraparound market determine levels of take-up in both these market segments.

11.3 Market Analysis Unit

In the 5-10 year old Holiday markets, parents predominantly access the provision to enable them to continue to work throughout school holiday periods and therefore, generally drop-off and collect their children in line with their work patterns. As a result, in Halton the assessment of childcare sufficiency in the 5-10 year old Holiday market needs to take place town-wide i.e. across Runcorn and across Widnes.





12.0 Findings

12.1 Childcare for 0-2 Year olds

The assessment of sufficiency of 0-2 year old childcare takes place at the sub-local authority level of Runcorn and Widnes. The Childcare Sufficiency Assessment found that there is sufficient 0-2 year old childcare in both Widnes and Runcorn. The impact of the extension of the 2 year old free entitlement, from 2013 -14 will create additional demand for places. To ensure continued sufficiency the 0-2 year old population will need to be monitored annually.





On average 66% of the provision of 0-2 year old childcare received a "Good or better" outcome grade from Ofsted.

In Runcorn 94% of 0-2 Year old places are provided by the private or voluntary sectors.

In Widnes 87% of 0-2 Year old places are provided by the private or voluntary sectors.


There are an estimated 72 children aged 0-2 years with a disability living in Runcorn and 65 children aged 0-2 years with a disability living in Widnes. All childcare providers have Inclusion Policies in place to ensure that the children's needs are met. The Disabled Children's Access to Childcare (DCATCH) programme aims to improve the take up of formal childcare by children with disabilities.


The average price of a 0-2 year old full day place in Runcorn is £155.96 per week.

The average price of a 0-2 year old full day place in Widnes is £153.33 per week.

12.2 3 and 4 Year old Wraparound Childcare

The assessment of sufficiency of 3 and 4 year old wraparound childcare takes place at the sub-local authority level of Runcorn and Widnes. The Childcare Sufficiency Assessment found that there is sufficient 3 and 4 year old wraparound childcare in both Widnes and Runcorn.





On average 66% of the provision of 3 and 4 year old wraparound childcare received a "Good or better" outcome grade from Ofsted.

In Runcorn 94% of 3 and 4 Year old wraparound childcare places are provided by the private or voluntary sectors.


In Widnes 87% of 3 and 4 Year old wraparound childcare places are provided by the private or voluntary sectors.


12.3 3 and 4 Year old Free Entitlement


The assessment of sufficiency of the 3 and 4 year old Free Entitlement takes place at the sub-local authority level of Children's Centre Reach Areas.


The Childcare Sufficiency Assessment found that there is sufficient provision of the Free Entitlement in six of the eight reach areas.


















Upton and Kingsway Children's Centre Reach Areas have insufficient provision.





Ditton Children's Centre Reach Area

On average 57% of the provision of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted. In this Children's Centre Reach Area, 55% of 3 and 4 Year old Free Entitlement places are provided by the voluntary sector and 45% by the maintained sector.

Kingsway Children's Centre Reach Area

On average 60% of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted.

In this Children's Centre Reach Area, 82% of 3 and 4 Year old Free Entitlement places are provided by the maintained sector and 18% by the private sector.

Upton Children's Centre Reach Area

100% of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted.

In this Children's Centre Reach Area, 85% of 3 and 4 Year old Free Entitlement places are provided by the voluntary sector and 15% by the private sector.

Warrington Road Children's Centre Reach Area

89% of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted.

In this Children's Centre Reach Area, 52% of 3 and 4 Year old Free Entitlement places are provided by the private and voluntary sectors and 48% by the maintained sector.

Brookvale Children's Centre Reach Area

69% of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted.

In this Children's Centre Reach Area, 75% of 3 and 4 Year old Free Entitlement places are provided by the private and voluntary sectors.

Halton Brook Children's Centre Reach Area

89% of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted.

In this Children's Centre Reach Area, 59% of 3 and 4 Year old Free Entitlement places are provided by the Maintained sector and 36% by the voluntary sector.

Halton Lodge Children's Centre Reach Area

64% of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted.

In this Children's Centre Reach Area, 100% of 3 and 4 Year old Free Entitlement places are provided by the private and voluntary sector.

Windmill Hill Children's Centre Reach Area

78% of 3 and 4 Year old Free Entitlement providers received a "Good or better" outcome grade from Ofsted.




12.4 5-10 Year old Out of School Childcare

The assessment of sufficiency in the 5-10 Year old Out of School Childcare market takes place at the sub-local authority level of Children's Centre Reach Areas.


The Childcare Sufficiency Assessment found that there is sufficient provision in two of the eight reach areas.


Warrington Road and Brookvale Children's Centre Reach Areas have sufficient provision.






















Ditton Children's Centre Reach Area

54% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.

In this Children's Centre Reach Area, 62% of Out of School places are provided by the private and voluntary sector, 25% in the maintained sector and 13% provided by school governing body

Kingsway Children's Centre Reach Area

40% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.

In this Children's Centre Reach Area, 100% of Out of School places are provided by the private sector.

Upton Children's Centre Reach Area

79% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.

In this Children's Centre Reach Area, 55% of Out of School place are provided by the private and 45% by the voluntary sector.

Warrington Children's Centre Reach Area

57% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.

In this Children's Centre Reach Area, 91% of Out of School place are provided by the private and voluntary sectors and 9% by a school governing body.

Halton Lodge Children's Centre Reach Area

58% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.

In this Children's Centre Reach Area, 100% of Out of School place are provided by the private sector.

Halton Brook Children's Centre Reach Area

58% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.

In this Children's Centre Reach Area, 58% of Out of School place are provided by the voluntary sector and 42% by the private sector.

Brookvale Children's Centre Reach Area

61% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.

In this Children's Centre Reach Area, 71% of Out of School places are provided by the private sector, 9% voluntary sector and 20% by a school governing body.

Windmill Hill Children's Centre Reach Area

54% of 5-10 year old Out of School Childcare providers were graded "Good or better" by Ofsted.In this Children's Centre Reach Area, 71% of Out of School places are provided by the private sector and 29% by the voluntary sector.

12.5 11-14 Year olds (or 17 for young people with disabilities) Out of School Childcare

As part of the Childcare Sufficiency Assessment process young people aged 11-17 were surveyed to determine the demand for childcare.

The survey was carried out by Extended Services workers in both Widnes and Runcorn and included young people from Halton's Secondary schools.

The survey indicated that 63% of respondents do not require childcare or extended school activities, with 23% responding that they think that they need childcare or extended services.

When respondents were asked why they did not require childcare, 52% replied "I'm old enough to look after myself" and 39% said that "I go to family and friends".

The survey indicated that young people aged 11-14 do not readily identify with the notion of "childcare", with those respondents claiming to require an after school activity, listing the following as their preferred activities: rugby; football; basket ball; cricket; swimming; acting and boxing.

12.6 5-10 Year old Holiday Childcare

The assessment of sufficiency of 5-10 year old holiday childcare takes place at the sub-local authority level of Runcorn and Widnes. **The Childcare Sufficiency Assessment found that there is sufficient 5-10 year old Holiday childcare in both Widnes and Runcorn.** To ensure continued sufficiency the 5-10 year old population will need to be monitored annually.

12.7 11-14 Year old (or 17 for young people with disabilities) Holiday Childcare

As part of the Childcare Sufficiency Assessment process young people aged 11-17 were surveyed to determine the demand for childcare.

The survey was carried out by Extended Services workers in both Widnes and Runcorn and included young people from Halton's Secondary schools.

The survey indicated that 49% of respondents do not require childcare or extended school activities, with 23% responding that they think that they need childcare or extended services.

The survey indicated that young people aged 11-14 do not readily identify with the notion of "childcare", with those respondents claiming to require an after school activity, listing the following as their preferred activities: rugby; football; basket ball; cricket; swimming; acting and boxing.
